TO THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

San Gabriel Valley Water Company ("San Gabriel") hereby requests ministerial review of the following changes in tariff sheets applicable to its Los Angeles County and Fontana Water Company divisions:

An original and four copies of this advice letter are submitted in compliance with General Order 96-B. This is designated as a Tier 1 advice letter, with a requested July 1, 2011 effective date.

Purpose

The purpose of this advice letter is to supplement San Gabriel's approved tariffs with two multi-language forms of Tenant Notification about discontinuance of water service.

Discussion

Sections 777 and 777.1 of the Public Utilities Code were amended by Senate Bill 120 in 2009. Section 777.1 (b) as amended applies to individually-metered residential water service to residential occupants in a detached single-family dwelling, multi-unit residential structure, mobile home park, or permanent residential structure in a labor camp, where a landlord-tenant relationship exists, and the owner, manager, or operator is the customer of record. When the account is in arrears, the water utility is required to make every good faith effort to inform the residential occupants by means of a specified written notice, at least 10 days prior to

discontinuance of water service, that they have the right to become customers to whom the service will then be billed, without being required to pay any amount which may be due on the delinquent account. Section 777.1 (c) provides for a similar notification where service is provided by the water utility through a master meter. In that case, a written notice must be posted on each door at least 15 days prior to discontinuance of water service. Both required notices must be in English, Spanish, Chinese, Tagalog, Vietnamese, and Korean. San Gabriel has complied with these statutory requirements and requests in this advice letter to add the attached sample forms to its approved tariffs.

The proposed tariff sheets are submitted in accordance with General Order No. 96-B, Section 8.5.8 "Sample Forms".

In accordance with the requirements of Water Industry Rule 4.1 of General Order No. 96-B, this advice letter is being sent to the parties listed on the attached distribution list. No other parties have requested notification of tariff filings related to the Los Angeles County or Fontana Water Company divisions.

This advice letter will be posted on San Gabriel Valley Water Company's website and Fontana Water Company website under the advice letter filings.

Protest and Responses

Anyone may respond to or protest this advice letter. A response supports the filing and may contain information that proves useful to the Commission in evaluating the advice letter. A protest objects to the advice letter in whole or in part and must set forth the specific grounds on which it is based. These grounds are:

- (1) San Gabriel did not properly serve or give notice of the advice letter;
- (2) The relief requested in the advice letter would violate statute or Commission order, or is not authorized by statute or Commission order on which San Gabriel relies;
- (3) The analysis, calculations, or data in the advice letter contain material error or omissions;
- (4) The relief requested in the advice letter is pending before the Commission in a formal proceeding;
- (5) The relief requested in the advice letter requires consideration in a formal hearing, or is otherwise inappropriate for the advice letter process; or
- (6) The relief requested in the advice letter is unjust, unreasonable, or discriminatory, provided that such a protest may not be made where it would require relitigating a prior order of the Commission.
